The Affiant certifies as true and correct that the architect defined in NRS 623.017 and authorized to receive a preference on public works projects by meeting criteria defined in NRS 338 referenced above has, while licensed as an architect in this state:

(a) Paid directly, on his or her own behalf:

1. The excise tax (modified sales tax) imposed upon an employer by NRS 363B.110 of not less than \$1,500 for each consecutive 12-month period for 36 months immediately preceding the submission of the affidavit from the certified public accountant; or
2. Acquired, by purchase, inheritance, gift or transfer through a stock option plan, all the assets and liabilities of a viable operating business that engages in the practice of architecture.
  - a. Satisfies the requirements of NRS 623.350; and
  - b. Possesses a certificate of eligibility to receive a preference when competing for public works.
3. Compliance with the provisions of SB 268 (2011)
